- Once an application is accepted, vendor fees are non-refundable except at the discretion of the MV Heritage Days Inc.
- The Heritage Days Inc. is not responsible for loss, thefts, damage or accidents.
- For-profit businesses are liable for obtaining a Sales Tax Permit. Call the Iowa Dept. of Revenue at 319/362-3613, ext 14 or dial toll-free 1-800-367-3388.
- All vendors are responsible for obtaining a temporary food service permit. Contact Linn County Public Health at 319-892-6000 or go to website [www.co.linn.ia.us](http://www.co.linn.ia.us) to apply.
- Food Vendors may not have exclusive rights to a food type, we will allow only two vendors per type of food (exclusive of hamburgers and hot dogs).
- Heritage Days inc. has reserved the exclusive right to sell **bottled water & bottled soda**.

For the first time in several years, Heritage Days is partnering with a carnival rides operator/supplier.

Our contract with Next Generation Shows precludes Heritage Days from partnering with food vendors that offer the following items: Funnel Cakes, Cotton Candy, Corn Dogs, Popcorn, Snocones, Caramel Apples and Lemonade

Shake-ups.

However, and because some of our regular food vendors offer some of the above items, the Heritage Days committee has been given a waiver on some of these items with the understanding that if these particular items are sold, that they will be sold at the same prices as Next Generations Shows sells the same items:

Lemonade \$3 and \$6

Corndogs \$3 and \$6

Funnel Cakes \$5

Other exceptions can be made if the Heritage Days Committee is made aware BEFORE receipt of this application.

**-- NOTE: Heritage Days is committed to Zero-Waste. To that end, all vendors are required to use compostable plates, cups, napkins, utensils and serving gloves. Recyclable plastic containers will be considered but only with prior approval by the committee. The committee plans to work with Compost Ninja throughout the day and are requiring all vendors to bring compostable (or with prior permission, recyclable) serving products.
